Alabama Office of Lt. Governor Statutory Duties

As of June 2, 2016

Summary

The Alabama lieutenant governor has more than thirty (30) statutory duties. These duties include serving as a member of more than 20 boards or entities, and appointing 400 positions to approximately 167 boards and commissions. The state **constitution** says the lieutenant governor shall be president of the senate.

The lieutenant governor has additional duties created by the state constitution, Governor's executive order, legislative act, and the Rules of the Senate. For example, chairing the Alabama Job Creation & Military Stability Commission is a significant duty of the office, but that duty is established by legislative resolution rather than statute. This paper addresses statutory duties.
