

Indiana Office of Lt. Governor Statutory Duties

Summary

The Indiana lieutenant governor has twenty-six (26) statutory duties. These duties include serving as Secretary of Agriculture and Rural Development. The lieutenant governor oversees the offices of tourism, defense development, and small business and entrepreneurship. S/he chairs the Councils leading Tourism, Counterterrorism and Security, and Main Street. The lieutenant governor also has duties including industrial development, senior citizens, housing, energy, and more. The state **constitution** says the lieutenant governor shall preside over the senate.

The Indiana **Constitution** states that the Lieutenant Governor:

- 1. Shall become Governor if the Governor resigns or dies in office, and Act as Governor in the event of incapacitation of the governor (Art 5 Sec 10)
- 2. Preside over the Indiana Senate (Art 5 Sec 21)
- 3. Cast the tiebreaking vote in the event of an equally divided Indiana Senate vote (Art 5 Sec 21)
