#### WHY NLGA?

The National Lieutenant Governors Association is the premier association for the nation's lieutenant governors and seconds-in-command of the states and territories. **NLGA brings together these leaders to discuss policy, share best practices, and build relationships** that will help improve the efficiency and effectiveness of state government.

#### LIEUTENANT GOVERNORS LEAD:

<u>NLGA Members</u> have a diverse array of important duties in state government, command public influence on legislation and policy, and they become Governor at a greater rate than any other official. About half of NLGA Members preside over their state's senate, and many oversee important departments and policy issues. *Every NLGA Member is their state or territory's gubernatorial successor – second in line to governor*.

#### PARTNER WITH NLGA AND BUILD RELATIONSHIPS:

The <u>NLGA Partners Program</u> is an opportunity for the private sector, nonprofits, associations, and other entities to share their expertise with NLGA and NLGA Members. Benefits include <u>meeting registrations</u>, opportunities for input on policy discussions, and the chance to build sustaining relationships with state government leaders and future governors.

NLGA Partnership is \$10,000 annually, billed on a rolling basis, based upon when the organization joins. **Partnership includes the following benefits, beginning May 2025:** 

- Two complimentary registrations to the 2025 NLGA Annual Meeting (July 16-18, 2025) in Lake Tahoe, Nevada
- One complimentary registration to the 2025 NLGA Meeting (December 5-7, 2025) in St. Thomas, USVI

- Access to advance registered attendees lists one week prior to all NLGA meetings
- Participation in the policy development process through <u>consensus resolution submissions</u> and suggested speakers for presentations and panels
- Opportunity to submit policy resources for *State Strategies Perspectives* and *Partners Policy Resources*, sent to all NLGA Members and their staff

- Opportunities to attend virtual training, professional development, and policy sessions as scheduled by NLGA
- Included in distribution of monthly e-newsletter highlighting work of NLGA Members, Partners, and other news
- Recognition year-round as a sustaining NLGA Partner on <u>NLGA website</u>, meeting signage and agenda books

NLGA meetings are closed, intimate gatherings of the nation's seconds-in-command, staff, NLGA Partners and meeting sponsors. The average meeting size is 100 total attendees, and the ONLY way to attend these meetings is as a Partner or sponsor.
